Term

This is an interim appointment with the term ending at the 2026 Annual General Meeting.

Commitment

- Prepare for and attend quarterly full-day board meetings for the duration of the appointment, the annual general meeting, and additional special meetings as needed.
- Participate in board committees and task forces, as needed.
- Actively participate in board communications and training.

Key Responsibilities

- <u>Public Protection</u>: Always act honestly, in good faith, and in the public interest.
- <u>Compliance</u>: Comply with the Act, Regulations, Bylaws, policies, and other governing documents of CPNL.
- <u>Respect</u>: Act in a respectful and courteous manner and foster an environment that is free from harassment and discrimination, culturally safe, and that values diversity.
- <u>Ethics</u>: Do not use information obtained through their position as a board member for personal gain and must not accept inappropriate gifts, entertainment, hospitality, or favours.
- Preparedness: Stay informed on matters relevant to governing CPNL and actively monitor for and review correspondence on board issues. Review all required materials in advance of board meetings and come prepared to fully participate in discussion on the matters listed on the meeting agenda.
- <u>Participation</u>: Participate actively and constructively in the business and discussions of the board and share ideas and opinions on relevant issues.
- <u>Competence</u>: Exercise the care, diligence, and skill of a reasonably prudent person in comparable circumstances.
- <u>Confidentiality</u>: Sign and adhere to the CPNL Confidentiality Agreement, and all confidentiality requirements established by law.
- <u>Conflicts of Interest</u>: Avoid and report all conflicts of interest stepping back from relevant discussions or decisions as appropriate.
- <u>Unity</u>: Support decisions of the board, whether or not they voted in favour of the decision.
- Organizational Reputation: Avoid any conduct that may bring the reputation of CPNL into disrepute.
